Unfair or Wrongful Dismissal Claims

Each claim is different and the overall cost will depend on multiple factors in particular the specific circumstances, any additional claims to be included e.g. discrimination, whistleblowing, the complexity of the issues, length of any tribunal hearing and whether Counsel is instructed to conduct the hearing.

Key Stages

The usual steps in a claim include:

- Bringing or resisting the claim
- Disclosure of evidence
- Preparing witness statements
- Attending the hearings
- Dealing with settlement, this could include attending judicial mediation
